## 2016-2017 Preschool and Kindergarten Tuition

Our Preschool and extended-day Kindergarten programs are made possible by your tuition payments. Tuition is collected by a third party tuition collection service, FACTS Management. FACTS serves over 5,000 schools nationwide and is the industry leader in tuition collection for public and private schools. No payments will be accepted at the school.

We will set up billing during the summer, and your deadline to set up an automatic payment plan or pay in full is the first day of school. Tuitions for the 2016-2017 school year are:

- Full-Day Kindergarten: \$325/month, \$3250 for the year
- Preschool has a selection of options with a variety of monthly rates:

You will receive a notice (by email or paper) from FACTS Management with directions to log in and set up your payment plan, or make payment in full. Members of the FACTS team are available to assist you with the payment process at 866-441-4637. If you have paid tuition or fees before through FACTS you may use your existing user name and password to set up this year's payment. No payment will be made without your authorization each school year.

Payment plans will debit your bank account on either the 5<sup>th</sup> or the 20<sup>th</sup> of each month. If you wish to pay on the 20<sup>th</sup>, you must enroll in a payment plan no later than **August 16<sup>th</sup>**. In that case your payments will fall on the 20<sup>th</sup> of each month from August through May. If you enroll by **September 16<sup>th</sup>**, payments will fall on the 20<sup>th</sup> of each month through June. If you prefer to have payments debited on the 5<sup>th</sup> of each month, enroll by **September 1<sup>st</sup>** and payments will be taken from September 5<sup>th</sup> through June 5<sup>th</sup>. Direct debit payment plans are preferred, with no additional charge. Some credit cards may be used with your payment of a 2.75% surcharge. If you wish to pay by check or money order, you must pay in full for the year.

I ask that you make sure that the contact information, including email, for the person who will be responsible for making tuition payments is provided to the Delaney School office when you register your student. The invitation to set up your payment plan will come by email from [noreply2@factsmgmt.com](mailto:noreply2@factsmgmt.com) or a similar email address. Please watch for it in early August.

Although FACTS is used to pay tuition and fees, the District still has full control over all decisions related to payments.
