

Wrentham Public Schools

The Wrentham Public School District announces that it will again participate in the National School Lunch and Breakfast Program. All students need new free and reduced meal applications. All children in the same household may be listed on one application. Please list students' name and the school they attend. Any student attending a school out of the Wrentham Public School District must apply at that school. Students may turn in their application at any school. Students eligible for Free Lunch at the end of June will be eligible while new applications are being processed. Free and Reduced applications are accepted anytime during the school year.

If families are denied lunch assistance because their income is slightly higher than the allowed amount, it is suggested that you apply at your local Transitional Food Stamp Office. If you are accepted, you will qualify for assistance through the National School Lunch Program. Just send in your acceptance letter with your child.

If you receive a letter from the school Food Service Director prior to school starting, stating that your child is eligible for free lunch through the Virtual Gateway, there is no need to fill out another application. If all children are not on this letter please call Lisa Luce, 508-384-5430 x1071. Please keep the letter for your records so that you can apply for fuel assistance and other programs.

How does a family qualify for assistance? Families can print out the 2024-2025 Massachusetts Application for Free and Reduced-price school meals. The application may also be obtained from the Wrentham Public Schools Main Office at any time throughout the year. The Food Service Department requests that parents or guardians complete these forms and return the completed forms to their child's school inside a sealed envelope addressed to: NPS Food Service
